US COAST GUARD HISTORY

The United States Coast Guard (USCG) is a military branch within the U.S. armed forces charged with the enforcement of maritime laws. It consists of approximately 35,000 officers and enlisted personnel, in

addition to civilians, under the jurisdiction of the Department of Homeland Security. In time of war, it functions as part of the U.S. Navy and is under the direction of the president.

The USCG was established Aug. 4, 1790 by Secretary of the Treasury Alexander Hamilton as the Revenue Marine Service. It later became the Revenue Cutter Service and, in 1915, was combined with the U.S. Lifesaving Service (formed 1878) to become the Coast Guard. It was under the (peacetime) jurisdiction of the Treasury Department until 1967, when it was transferred to the Department of Transportation. In 2003 the Coast Guard was placed under the jurisdiction of the newly created Department of Homeland Security. The Coast Guard enforces all applicable federal laws on the high seas and waters within the territorial jurisdiction of the United States. It administers laws, as well as promulgates and enforces regulations for the promotion of safety of life and property along the entire U.S. coast, including Alaska and Hawaii, Guam and American Samoa. It develops and operates aids to navigation in order to maintain the safety of ports and vessels in U.S. territorial waters.

The peacetime duties of the Coast Guard involve the inspection of vessels and their equipment and the direction and operation of lighthouses and buoys. Previously the USCG serviced such electronic navigational aids as loran (long-range navigation) stations and radio beacons. The Coast Guard maintains an extensive network of lifeboat and search-and-rescue stations using surface vessels and aircraft. It also operates the International Ice Patrol, which maintains surveillance of icebergs in the North Atlantic shipping lanes. The USCG also gathers data for the National Weather Service and assists distressed ships and planes. Wartime duties include escorting ships, securing ports, and manning transports. The Coast Guard also assists in the interdiction of illegal narcotics and illegal immigrants that enter the United States on or over coastal waters.

The Coast Guard's organization parallels that of the U.S. Navy, and the Coast Guard's ranks and ratings are identical to those of the Navy. The two services' uniforms are also similar. The USCG is headed by a

Coast Guard admiral, who is appointed by the president. The Coast Guard Reserve was established in 1939. Women have been permitted to serve in the regular Coast Guard since 1973. 

NATIONAL ZUCCHINI DAY!

August 8, 2023, is National Zucchini Day. It's also known as



Zucchini

"Sneak some zucchini onto your neighbor's porch day!" originated in Italy and can be tracked back to the 1850's but did not make it

to the US until the 1920's. Zucchini are loaded with vitamins, minerals, and fiber and have more potassium than bananas!

Do you remember the days when your neighbors grew huge vegetable gardens and grew zucchini? In the heat of the summer the zucchini would become so prolific that they would grow huge (actually overgrown) and they would pick them by the dozens, bag them up, and then you would find them on your porch, on your car seat (if you forgot to lock your car) or they would bring them to work and leave them on your desk when you weren't looking!

The problem with huge, overgrown zucchini, is that the skin becomes tough and fibrous, and the meat of the vegetable comes very watery and bland. My Mom would try to use these large monstrosities in soups, stews, or sometimes stuff them with meat and cheese. It was a valiant effort, but everyone groaned (to themselves) when they saw those huge things come out of the oven. We didn't dare complain out loud because we knew that was our only choice for dinner!

Today in the supermarkets our zucchini (also known as courgette overseas) are the perfect size for eating. The skin is soft, and the flesh is tasty. The key is knowing how to cook them properly.

These are two of our favorite recipes for zucchini. They are great as hors d'oeuvres and appetizers or served as a side dish to a summer meal.

Oven Baked Zucchini Sticks

Servings: 4

1 pound zucchini, cut into sticks 3" long, ¹/₄" wide 1 large egg, beaten

¹/₂ cup panko breadcrumbs (or regular unseasoned breadcrumbs)

 $\frac{1}{2}$ cup Parmesan cheese, grated

- 2 teaspoon dried oregano
- ¹/₂ teaspoon salt

¹/₂ teaspoon black pepper

¹/₂ teaspoon granulated garlic

Preheat oven to 350 degrees F. Cover sheet pan with parchment or foil and spray with non-stick cooking spray.

Combine breadcrumbs with Parmesan, oregano, salt, pepper and garlic in bowl.

Dip zucchini in beaten egg, allowing excess to drip off. Dredge in bread crumb mixture then place on prepared pan. Cook in oven for 15-20 minutes or until lightly browned and crisp. Serve hot. These taste great with your favorite Ranch or Bleu Cheese dressing!

Zucchini Fritters Servings: 4

1¹/₂ pounds zucchini, coarsely grated

³/₄ teaspoon salt ¹/₄ cup all-purpose flour

¹/₄ cup Parmesan cheese

1 large egg, beaten

2 cloves garlic, minced

4 green onions, chopped fine

Salt and pepper to taste

Olive oil for frying



Toss zucchini with salt in large colander and place in sink to drain for 20 minutes.

Squeeze zucchini as dry as possible with your hands (or use cheesecloth).

Mix flour, parmesan, egg, garlic, salt, pepper, and green onion in bowl. Stir in zucchini.

Heat oil in large non-stick pan over medium heat.

Working in batches, scoop tablespoons of zucchini mixture onto hot skillet, use back of spoon to flatten out. Fry until golden brown and flip (about 2 minutes per side). Serve hot and enjoy. These are delicious with a dollop of sour cream, tzatziki sauce or just plain nonfat Greek yogurt!

HEAT AND AGE OF GOLF CART BATTERIES

What Affects Golf Cart Battery Water Levels?

During a recent encounter with a friend, whose name I will not mention, she asked to check the water levels of her golf cart batteries. I wasn't able to get

back to her for a couple of days, but she wasn't concerned because she said she hadn't used her golf cart very much in the last couple of months. When I was able to open up the batteries and check, none of the cells had water covering the plates. She was a victim of a major misconception ...

The number one rule for golf cart battery maintenance is to never let your water level go below the top of the plates.

Heat and Age of Golf Cart Batteries

While it is true that the more you use your golf cart the more frequently you need to check water levels, it's also true that there are other



considerations that affect how frequently you should open up your battery cells. More frequent monitoring is also required in hot temperatures and with batteries that are older.

I find that new and "old" golf cart owners often don't understand that this easy-to-do maintenance on their golf cart can save them hundreds of dollars. **Batteries that are left "under-watered" have a shorter lifespan and need to be replaced sooner than those that are kept at the optimal water level.**

FMO MEMBERSHIP DUES INCREASE

For the first time in over ten years, FMO dues will increase. 


